PRESIDENT'S MESSAGE

Douglas E. McKinney, M.D.

As the Summer of 2007 comes to a close, it is time to look forward to our 65th Annual Meeting in Bermuda. I am pleased to report that the Mid-Atlantic Section has a comprehensive scientific and social program planned and this year's event will be a memorable one for all who attend.

Under the leadership of Dr. Harry Koo, the 2007 Program Committee has selected 30 podium presentations, 7 of which will be part of the annual resident prize essay competition. New this year will be a Practice-Based Scientific Session on Sunday morning featuring 5 presentations that offer innovative surgical techniques useful in everyday practice. 23 posters are also planned for Bermuda and are divided into two moderated sessions that will kick off the program on Thursday afternoon.

Other features of the scientific portion include: an optional ultrasound course broken out into two, 2-hour sessions providing both didactic and hands-on ultrasound training for urologists; panel discussions on recent initiatives with respect to BPH, erectile dysfunction, incontinence, and pediatric urology; industry-supported scientific symposia; and our annual Howard Pollack X-Ray conference with Dr. Robert Older returning as moderator.

SECRETARY - TREASURER'S CORNER

The Mid-Atlantic AUA Board of Directors has had a busy year and what follows is a recap of Board discussions and actions to date in 2007.

In my role as Secretary-Treasurer, I have served on the AUA Bylaws Committee and recently shared with the Board proposed amendments to both the AUA (c)6 and AUA (c)3 Bylaws documents. These include a change from age 62 to 65 on Senior Membership age eligibility, changes regarding Honorary Member selection, and a significant restructure with respect to the existing AUA committees. Those Bylaws amendments were promulgated to the AUA membership at the May 2007 Annual Business Meeting in Anaheim.

An update from the AUA on its two new membership categories, Allied and International Residents-in-Training, has been reviewed and discussed. The AUA's position is that eligible participants for Allied membership would include urologic health-care professionals - nurses (RN/NP/LVN/LPN/CNS), physician's assistants, technicians and medical assistants. Our Mid-Atlantic Board decided it would not incorporate these categories into the MA-AUA structure at the present time but would look into what other Sections are doing before proceeding.

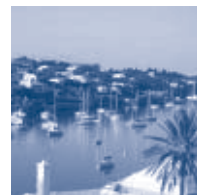

Recent Activities of the MID-ATLANTIC SECTION
of the AMERICAN UROLOGICAL ASSOCIATION BOARD OF DIRECTORS
Summarized from the Board of Directors Meeting, March 26 , 2007

PRESIDENT'S REPORT

Plans for the 65th Annual Meeting in Bermuda were proceeding and Dr. McKinney announced his choice for the 2007 Hugh Hampton Young Lecturer; Elliott E. Maynard, a Justice for West Virginia Supreme Court.

SECRETARY-TREASURER'S REPORT

The CPA Review for the fiscal year ending December 31, 2006, conducted by Russell, Brier and Company of Boston, Massachusetts provided a clean opinion. In reviewing the Statement of Assets, Dr. Lippert noted the Section's total assets of \$958,061. Total Revenue of \$526,666 against total expenses of \$403,451 resulted in a surplus of \$123,215.

The unaudited financial report for the period ending December 31, 2006 and proposed budget for 2007 had been distributed for consideration. A review of the unaudited financial report for the period ending February 28, 2006 reported that total assets of \$964,879 compared favorably to the \$860,594 for the same period last year.

AUA BYLAWS COMMITTEE

Dr. Lippert reported on proposed amendments to both AUA (c)6 and AUA (c)3 bylaws that included: a change from age 62 to 65 on Senior Membership age eligibility, changes regarding Honorary Member selection, and a significant restructure with respect to the existing AUA committees.

AUA ULTRASOUND FACULTY

Daniel B. Rukstalis, MD and Edouard J. Trabulsi, MD were approved and submitted by the Board as willing to participate as faculty members for the new National Urologic Ultrasound Faculty (NUUF).

AUA LEADERSHIP PROGRAM

Drs. Chai and Eure commented on their experiences with the Leadership Program to date. They shared very positive feedback and thought the program was both valuable and insightful. Various Board members also spoke about the quality of the program and opined how it would help participants grow with respect to leadership within the AUA and its Sections.

REPORT OF THE HISTORIAN

Dr. Dan Dietrick updated the Board on the latest projects being undertaken including a recent initiative to collect old books, photographs, and urologic instruments that would represent the history of the specialty. He also reported that this year's subject of Women in Urology was doing well. Dr. Sakti Das, of the Western Section, was appointed as the AUA Historian.

REPORT OF THE REPRESENTATIVE TO THE AUA BOARD OF DIRECTORS

Dr. Thomas Rohner reported on the recent actions of the AUA Board of Directors as of February 16-21, 2007, including: finalization of the AUA National Meeting Program in Anaheim which would feature progressive modules in ultrasound, endourology, and imaging (approval for subcommittees related to these modules had also been approved); an update of the guidelines for the Management of Clinically Localized Prostate Cancer; efforts to establish additional restrictions with respect to conflicts of interest and AUA leadership positions; expansion of education and membership offerings on an international scale; and the development of a core curriculum in Urology as an important part of residency training.

AUA COMMITTEES AND REPRESENTATIVES

AUA CODING AND REIMBURSEMENT COMMITTEE

Dr. Roger Schultz highlighted recent activities and recommendations: a recommendation on transurethral radiofrequency energy treatment to not approve Category 1 code status for CPT 2008; a recommendation on percutaneous cryoablation of renal tumors to move from Category 3 to Category 1 code status; a recommendation on HOLEP to move to Category 1 status; formalizing a collaborative relationship with McKesson a software firm; urologists needing to provide more documentation on urodynamic assessment results; ongoing response to carriers that refuse payment for selected procedures; CMS plans to develop episode groupers for selected diseases; advise to carriers that they should pay for any bulking agent that is FDA approved; update on communications with Highmark regarding surgical codes and TRUS; review of regulatory updates summarized in the Health Policy Brief; support on reimbursement for Deflux which is used to treat vesicoureteral reflux; a vote to delete code 52510 (transurethral balloon dilation of prostatic urethra) which is no longer done; Aetna, in Michigan, bundling UA with E&M codes; a review of all GU procedures for which compensation is needed for an assistant surgeon.

LOCAL ARRANGEMENTS COMMITTEE

Dr. Stanley Zaslau, Local Arrangements Chair, provided a written report summarizing the social plans for the Bermuda meeting.

PROGRAM COMMITTEE

Program Committee Chair, Dr. Harry Koo, outlined the proposed panels and sessions for each day of the Annual Meeting, including the integration of an optional ultrasound course.

OLD BUSINESS

EXHIBITOR EVALUATIONS

The 2006 Exhibitor Evaluation results provided positive feedback noting that the involvement of industry with the Friday night Welcoming Reception and “Spy” theme festivities was very well received.

501(c)3 PROPOSED BYLAWS

Proposed Bylaws for a new 501(c)3 to be established along with the present 501(c)6 so that governance can more closely mirror the governance structure of the AUA had been distributed. Seeing the 501 (c)3 is a separate entity, this business was undertaken as a separate session immediately following the main Board meeting. The proposed name of the new 501(c)3 is the “MA-AUA Education Fund, Inc.”

AUA UPDATE ON MEMBERSHIP CATEGORIES

Allied and International Residents-in-Training categories are now established by the AUA. Allied membership would include urologic health-care professionals - nurses (RN/NP/LVN/LPN/CNS), physician’s assistants, technicians and medical assistants. The Board determined that the Section would not incorporate these categories at present. The consensus was that adopting these categories would probably be a good idea in the long term.

NEW BUSINESS

NOMINATIONS FOR THE JOURNAL OF UROLOGY EDITORIAL BOARD

Dr. Burkhardt Zorn completed his term on the Editorial Board of the *Journal of Urology* on June 30, 2007. The AUA had requested the early submission of three candidate names to replace Dr. Zorn.

PROPOSED PARLIAMENTARIAN POSITION

The Board agreed to appoint Dr. Kretkowski as Parliamentarian for the Annual Business Meeting in Bermuda. Future re-appointments would be made by the sitting President as needed.

PROPOSED JOINT ANNUAL MEETING WITH THE NEW ENGLAND SECTION OF THE AUA

Following discussion, the Board voted to accept the offer from the New England Section to have a Joint Annual Meeting in 2011.

American Urological Association Board of Directors Report

The AUA Board of Directors met in May at the Anaheim Hilton and will meet in Baltimore on October 11- 14, 2007 just one week before our Mid-Atlantic Section Meeting

The AUA has developed a new educational program “course of choice” for Section meetings. The Office of Education will select a menu of available annual meeting courses for the “course of choice” program. The AUA will pay expenses and honorarium for a speaker of the Section’s choice, if the Section meeting is held within Section boundaries, Canada, Mexico, and Bermuda. Sections that want to take advantage of this program need to make their request at least 90 days before their meeting.

The Anaheim Annual Meeting was very successful with 9,600 urologists attending (1,000 more than Atlanta); United States member attendance was increased with a slight decrease in international numbers due to new regulations in Spain and Italy which bar drug and device companies from paying expenses for urologists travel and meeting expenses.

Roger Dmochowski, Chairman of the AUA Guidelines Panel, reported that two new guidelines will be developed in 2008. These will be vasectomy and interstitial cystitis. They will be done jointly with the European Association of Urology, including sharing of costs. Several updated methodologies including new software have been developed which should shorten the time for guidelines development to two years and decrease costs.

After the loss of Marty Resnick, a Search Committee chaired by Past President Larry Ross, has been formed to identify a successor Editor of the *Journal of Urology*.

John Huber, Executive Director of the AUA Foundation has resigned and a search process is underway. An important qualification for his successor is a strong background in development for fundraising. The Foundation reserves have remained stable at about 5 million dollars for the past two years. The Foundation Development Council has been reorganized with Mr. Roger Herring from Chicago as Chair, and Richard Williams, MD as Vice Chair. The Council has named representatives from each Section to identify grateful patients for potential donations. Logan Holtgrewe has agreed to represent the Mid-Atlantic Section in this regard.

In January, the AUA requested the names of at least two practitioners who would be willing to participate as faculty members for its new National Urologic Ultrasound Faculty (NUUF). After a poll of the Board members had been conducted, the names of two members with expertise in this area were approved and submitted to the AUA.

In follow-up to the October 2006 decision for the MA-AUA to move to a dual-corporation structure, so that governance can more closely mirror the governance structure of the AUA, proposed Bylaws for a new 501(c)3 to be established along with our present 501(c)6 were reviewed and approved. The final process of establishing the 501(c)3, which will be named the "MA-AUA Education Fund, Inc.", is now underway. The New England and New York Sections are also in the process of finalizing their own dual-corporation structures which provides operational benefits from a number of standpoints.

A letter from the New England Section had been sent to my attention at the MA-AUA proposing a Joint Annual Meeting with the NE-AUA in 2011. The NE-AUA periodically participates in Joint Meetings, and has found that, in addition to diverse and high-quality sci-

entific sessions, they offer greater opportunities for collegial networking and sharing of ideas. The New England Section leadership had voted to approach the MA-AUA given our common management, which would help facilitate meeting planning and logistics. After discussion, the Board concurred that this would be a beneficial experience for both Sections and the offer was accepted. This joint meeting with the NE-AUA will take place in the Fall of 2011 at a resort location to be determined early next year.

As mentioned previously, we encourage both new and existing members to volunteer for future service within various appointed positions to the AUA as there have been many re-appointments in recent years. Questions about these positions can be directed to the MA-AUA Administrative Offices at:
