Recent Activities of the MID-ATLANTIC SECTION of the AMERICAN UROLOGICAL ASSOCIATION BOARD OF DIRECTORS

Summarized from the Annual Business Meeting, October 26, 2007

Report of the President

Dr. McKinney thanked the membership for their support during his Presidency over the last year and expressed his appreciation to Dr. Harry Koo, Program Committee Chairman and to Dr. Stanley Zaslau for his superb efforts in organizing the social activities in Bermuda.

Dr. McKinney reported that an excellent attendance of 162 pre-registered attendees, along with an added 16 onsite registrations, had been achieved for the 2007 Annual Meeting.

The AUA was seeking the names of people to consider for the position of Section liaison for the Development Council of the AUA; interested parties should contact the MA-AUA Administrative Offices.

Report of the Secretary-Treasurer

Dr. Marguerite C. Lippert, Secretary-Treasurer, reviewed the current membership statistics of the Section noting a total of 1,118 members in the Section with 677 Active, 278 Senior, 59 Associate, 4 Honorary, 4 Affiliate and 96 AUA Candidate Members.

Dr. Lippert reviewed the following actions of the Section's Board of Directors from the meetings on Monday, March 26, 2007 and Friday, October 19, 2007:

- The Board voted to accept an offer from the New England Section to have a Joint Annual Meeting in 2011. In addition to having diverse and high-quality scientific sessions, a joint meeting with another Section will offer greater opportunities for collegial networking and sharing of ideas. Both Boards have agreed that a venue out-of-both Sections, such as a resort location, would be preferred and various properties are presently being explored.
- The Board has continued to work with Mike Pretl, legal counsel at the AUA, on the establishment of the new 501(c)(3) entity, to be established along with the Sections 501(c)(6), so that governance can more closely mirror the governance structure of the AUA. Proposed Bylaws for the new 501(c)(3) have been adopted and Mr. Pretl has advised the Board that the final steps for establishing the new entity, which will be called the "MA-AUA Education Fund, Inc." are now taking place.
- The Board submitted the names of Dr. Daniel Rukstalis and Dr. Edouard Trabulsi to the AUA for the new AUA National Urologic Ultrasound Faculty. In addition, the Board submitted the name of Dr. Gerald Jordan as a replacement for Dr. Burkhardt Zorn, who had reached the end of his term, on The Journal of Urology Editorial Board.
- The Board agreed to endorse Dr. Majid Eshghi of the New York Section in his bid for the AUA Treasurer position opening in 2009.

- The Board agreed to participate with the AUA in their plan to create a Research Endowment through the AUA Foundation. The MA-AUA will contribute \$125,000 over the course of 3 years as part of this participation. Dr. Lippert noted that Dr. Schellhammer would be providing additional details on this program in his address that would follow the Annual Business Meeting.
- The Board agreed to support another IVUMed scholar in 2008 with a \$4,000 scholarship as this has proven to be a valuable ongoing program. As with previous IVU scholars that have been supported by the Section, it is being requested that a report be delivered by that individual to the membership after their work through the IVU has been completed. The Board also agreed to again participate in the AUA's 2008-2009 Leadership program.
- The Board accepted an offer from the *Canadian Journal of Urology* to have podium and poster abstracts from this Annual Meeting published in their upcoming December issue. Dr. Lippert noted that, if this proves to be a mutually beneficial arrangement, the CJU would publish abstracts from future Annual Meetings as well.
- The Board of Directors also approved all requests for changes in membership status and received a number of reports from Committees and AUA Representatives.

Dr. Lippert concluded the Report of the Secretary-Treasurer with the Section's financial records as of September 30, 2007 indicating that assets were \$1,176,468; total receipts for the first nine months of 2007 were \$374,105; and total disbursements were \$155,697; resulting in an operating surplus of \$218,408 before most figures pertaining to the 2007 Annual Meeting are included.

Report of the Representative to the AUA Board of Directors

Dr. Thomas Rohner detailed recent projects which included the Outreach Practice Program, the laparoscopic nephrectomy surgical simulator project, the expansion of the Section Secretaries Membership Council and the divisions that report to it, international initiatives, and various AUA staff changes.

Report of the Program Committee

Dr. Harry P. Koo reported that a total of 142 abstracts had been submitted for consideration by the Program Committee. The Program consisted of 30 oral presentations and 23 posters, 5 panel discussions and 3 special topic lectures, 1 special topics discussion along with the 2007 Hugh Hampton Young Lecture by the Honorable Elliott E. Maynard of West Virginia, the Howard M. Pollack X-Ray Conference conducted by Dr. Robert Older on Friday, and a coding seminar luncheon conducted by Stephanie Stinchcomb of the AUA on Saturday. An Ultrasound Training program, moderated by Dr. Daniel Rukstalis, was being conducted and had been divided into 2 afternoons; a Didactic Session on Friday and a Hands-On Session on Saturday. Attendees to the Didactic session will receive CME credit and an evaluation of proficiency test had followed that session. Attendees to the Hands-On session will receive CME credit and a Skills Level II Verification of skills, through the American Urological Association, will be provided to those who have also attended the Didactic session and have passed the evaluation of proficiency test. The Hands-On Training session would be open for those who have attended the Didactic Training session.

New Business

Proposed amendment to the ByLaws which addresses an age change from 62 to 65 to match the same recent AUA Bylaws change with respect to Senior Membership. It was proposed (and subsequently approved) that Section 4 of Article II be amended as follows:

iv. Senior Members

Active members in good standing in the Section on reaching the age of sixty five (65) years are eligible for Senior Membership provided they have been Active Members of this or another Section for at least twenty-five (25) years. Active members who are retired and have been members for twenty (20) years in this or another section, or are permanently disabled, are also eligible for Senior Membership.

Dr. Stanley J. Kandzari brought the issue of increased funding with respect to post-graduate education to the Members present and opined that the AUA National Office be approached on this. It was recommended that a letter be sent directly to the AUA offices. Other added discussion concerned a potential gallop poll to verify an apparent shortage of urologists on the national scale.

Dr. William Steers will begin a four year term as Editor of the Journal of Urology in January 2008. Be sure to read his opening editorial in the January 2008 issue.

Other Journal of Urology appointments include Dr. Deborah R. Erickson to Associate Editor, and Dr. Arthur Burnett, Assistant Editor.

The AUA has leased Washington, DC office space for occupancy December 1, 2007. This satellite office at the Hall of States building includes four private offices, a reception area, and work room. Several staff from the Government Relations, Health Policy and Advocacy Departments will be housed at this location convenient to Capitol Hill to better advance health policy issues for urologists.

In October 2007, the AUA Foundation Development Council proposed the creation of a matching program whereby each AUA section would endow in perpetuity an AUA Foundation Section Research Scholar from each of the 8 AUA sections. These endowments would be used as evidence that practicing urologists regard continuing research important both for our specialty and for patient care. This commitment would be seen as helpful in recruiting additional donor support for the Foundation.

The original proposal was for a 6 million dollar fund with 3 million dollars from the Sections and 3 million dollars from the AUA. This would have had each section contributing \$375,000 which the Board of Directors thought would be difficult for many Sections. The AUA then agreed to a 2 to 1 matching program whereby each Section contribution would be \$125,000 with the AUA contributing \$250,000 (in addition to their 3 million dollars). At this time the Mid-Atlantic, Western and North Central Sections have voted to approve funding for this important program. The South Central and Northeastern Sections have agreed and are finalizing details with other Section meetings scheduled later.

stage for the 2008 Hugh Hampton Young Lecturer, The Honorable Elliot E. Maynard of West Virginia, who delivered a unique message on "America's Courts" that was well-polished with exceptional anecdotal humor. Our Resident Prize Essay program took place on Friday morning and the winners are noted on page 3. My compliments to all of the young urologists who participated and congratulations to the winning authors. In total, 30 oral presentations, 5 panel discussions, and 4 special topic lectures were presented this year, along with a moderated session of 23 posters, making for a well-rounded weekend of quality education.

As mentioned earlier in this message, the MA-AUA has been a leader in taking on new endeavors. I am proud to report that our Section will be one of the first to work in tandem with the AUA, and the new AUA Foundation, on a new Research Endowment program through which a Research Fellow from each Section, bearing the Section's name, will be perpetually funded. As Dr. Paul Schellhammer, AUA President and Past-President of the Mid-Atlantic Section, explained to us in Bermuda this is an important project as the work of our investigators is directly related to the future of urology and, presently, that future is at risk due to recent cuts in national funding for research.

I am proud to report that our Section will be one of the first to work in tandem with the AUA, and the new AUA Foundation, on a new Research Endowment program through which a Research Fellow from each Section, bearing the Section's name, will be perpetually funded.

Last fall, the MA-AUA Board of Directors also accepted an offer by the Canadian Journal of Urology to publish abstracts from the 2007 Annual Meeting in their December issue. Copies of that issue were distributed to the MA-AUA Membership this past month and it is hoped that publication of our meeting abstracts in the CJU will continue in the years to come. I am also pleased to report that the MA-AUA establishment of a dual-corporation structure with the addition of a 501(c)(3), along with our present 501(c)(6), is now in the final stages. As the AUA and other Sections have this same governance structure, we can expect to benefit from a number of different operational standpoints.

In conclusion, I would like to thank my 2008 Annual Meeting Program Chair, Dr. Toby Chai, Local Arrangements Chair, Dr. Michael Phelan, their respective committees, the MA-AUA Board of Directors, and our other committees for the hard work already underway this year.

Thank you again for the privilege of serving as your president and I look forward to seeing you in Cambridge Maryland at the Hyatt Regency Chesapeake Bay for the 2008 Annual Meeting on September 25th to 28th.

International Volunteers in Urology (IVU) Scholar Report

Jonathan Taylor, MD, Eastern Virginia Medical Center / Nairobi, Kenya, April 2007
Mentor: Dr. Donald Lynch

Dr. Jonathan Taylor traveled to Nairobi, Kenya with mentor Dr. Donald Lynch to work with the medical staff and patients at St. Mary's Mission Hospital. Dr. Taylor participated in 27 procedures at St. Mary's.

About his experience, Dr. Taylor stated:

It is with special thanks to the Mid-Atlantic Section of the American Urological Association that so graciously made a grant to International Volunteers in Urology so that I could travel to Nairobi, Kenya for a mission trip this past spring. I will try to summarize below my experiences although I doubt either by word or written language I could express how valuable an experience this was.

I was able to participate in the operating room about four and one half days while I was in Kenya. Their system of care was quite different from what we in the United States are accustomed, and I was astounded by the efficiency of their surgical services.

St. Mary's is located (purposefully) next to one of the largest and poorest "slums" in the world. Kibera, as the slum is referred to, was recently popularized in the book and motion picture "The Constant Gardener." We met many of the children who lived there, some of which attend the school that the Catholic mission runs. Some of the poorest people in our country are much better off than

the tens, if not hundreds of thousands of people, who live there, as well as many other smaller "slums" around the city. Interestingly, as opposed to our culture, these poor people were very happy and had a great outlook on life and put a great deal of emphasis on education as a way out of poverty.

Overall this was an invaluable experience. Surgically, socially and academically I think that I returned a much better and more complete surgeon and person than when I left. The experience makes me much more appreciative not only of the world in which I live, but also in the broader world community. Currently I have plans to do presentations for the nursing staff at our hospital and at my local church in hopes of inspiring others to get involved in mission work in some facet. Hopefully, my program at Eastern Virginia Medical School can continue to foster this relationship to provide other residents with this type of experience.

One of the members of the group I am getting ready to join does mission work annually and we have discussed working on this as a long-term commitment. The experience I have described above only strengthens that commitment for future mission work; part of which I hope can be spent supporting the outreach programs of International Volunteers in Urology.

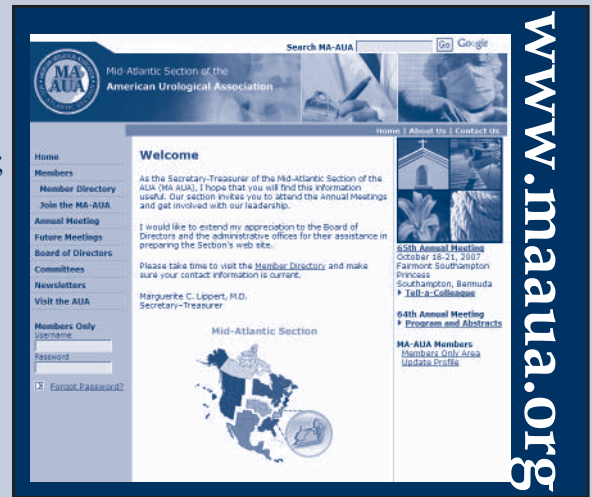
