22	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23	act may be cited as the "Continuing Care for Healthcare Providers Emergency Amendment Act
24	of 2022".
25	Sec. 2. Section 12 of the Health Services Planning Program Re-establishment Act of
26	1996, effective April 9, 1997 (D.C. Law 11-191; D.C. Official Code § 44-411) is amended by
27	adding new subsections (e) and (f) to read as follows:
28	"(e) Notwithstanding subsection (a) of this section, a certificate of need that expired after
•	
29	March 15, 2022, shall continue to remain effective and valid until 120 days after the end of the
30	Mayor's declaration of a public emergency pursuant to section 5 of the District of Columbia
31	Public Emergency Act of 1980, effective March 5, 1981 (D.C. Law 3-149; D.C. Official Code §
32	7-2304); provided:

- 33 "(1) The healthcare provider is currently providing services for at least 5 patients
  34 under the certificate of need; and
- 35 "(2) The healthcare provider applies for an initial license to operate within 30
  36 days of the effective date of this subsection.
- 37 "(f) The Department shall have 120 days to approve or deny an application for initial
  38 licensure made under subsection (e)(2) of this section.".
